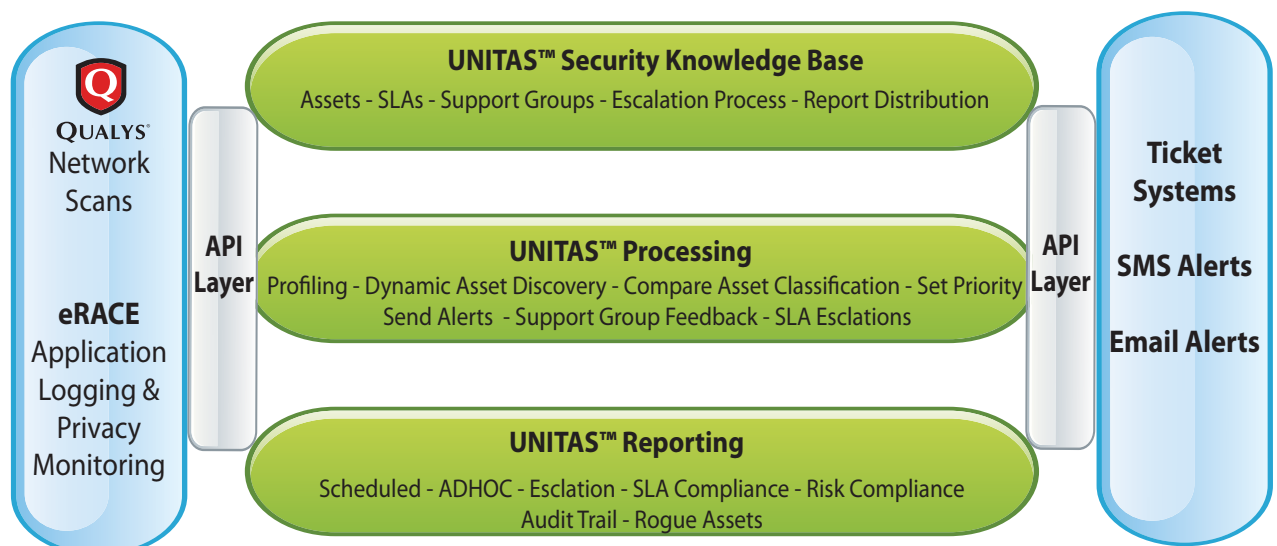
The Unitas integration with QualysGuard provides clients with the following capabilities and benefits:

Continuous monitoring of internal controls - the process of remediating escalated vulnerability and attack incidents is monitored against Service Level Agreements for business critical assets with the Unitas system. The **Incident Report** displays incidents that relate to Internal Control Sets and/or user activity that has been associated with your applications. It provides the ability to take action on the incidents that are associated with your applications.

Incident Management has tasks associated with it that may include just recording the incident in the master database of all incidents since the company began using the system or assigning the incident to a specialist. Progress is monitored and incidents can be resolved and then they are closed.

Tasks

- **Lock Tasks** Access this page to take ownership of tasks.
- **New Task** Access this page to enter a new task for a selected incident.
- **Unlock Tasks** Access this page to unlock tasks that require work although an administrator has taken ownership.
- **Work on Tasks** Access this page to record work done on tasks.
